

Context of the problems


- ❑ Disasters don't respect geo-political boundaries
- ❑ Disasters don't happen often enough for everyone to be practiced in their response
- ❑ Disasters aren't as predictable as we'd like
- ❑ Planning and practicing require time and money
- ❑ The **WHOLE COMMUNITY** must be involved

Disasters BEGIN as LOCAL problems

Disasters END as LOCAL problems



If your house catches on fire, it's YOUR PROBLEM.

- ❑ You'll get some help - Fire Department , EMS, Law Enforcement, Building Inspectors, Insurance Adjustors, Investigators, etc.
- ❑ Those same agencies will all go away, and you'll still have a burned-out house, which is YOUR PROBLEM – not theirs.
- ❑ The same thing occurs between different levels of government... Help may come from higher levels, but first and last it's a local problem.

The “Three C’s”

□ Communicate

- *Information is our most important resource*

□ Coordinate

- *Support separate units working together*

□ Collaborate

- *Work with others – Government, NGO, Private...*

Information Sharing

- ❑ Is there a system or tool in your county?
- ❑ If we don't hear from you, are you OK?
- ❑ We can't act without knowing the need
- ❑ If all else fails, try again!
- ❑ Don't ASSUME!



Command versus Coordination

- Command is directing the tactical response to an incident or event. It is usually done in close proximity to the scene, by people familiar with the specific response tactics.
- Coordination is supporting the response by ensuring adequate appropriate resources are available. It is usually done from an Emergency Operations Center, and is more strategic in focus.

FEMA, State, County, Municipal roles

- ❑ Planning spans different levels
- ❑ Resources come from different levels
- ❑ Collaboration and Cooperation vary
- ❑ Knowing each other is vital...
 - What you can / can't do
 - What you will / won't do
- ❑ Higher levels generally **SUPPORT** lower levels, not take over from a **COMMAND** perspective



Benefits during a disaster

Local Officials are...

- ❑ Geographically closest to the incident...
- ❑ Knowledgeable about the community...
- ❑ Impacted most directly...

Challenges during a disaster

Local Officials...

- ❑ Wear many different hats...
- ❑ Control relatively few resources...
- ❑ Have limited disaster training & experience...

County can HELP your community

- ❑ Situational Awareness (before and after)
- ❑ Wider net for resources
- ❑ Broader disaster experience

- ❑ Support things that YOUR TEAM isn't as good at or isn't prepared for

Emergency Operations Plan (EOP)

- ❑ Mandated by state rules
- ❑ Details for content / organization / review
- ❑ HOW the municipality organizes for disasters
- ❑ WHO is responsible for WHAT
- ❑ ANNEXES for specific functions & hazards

EOP Submission & Review

- ❑ Municipal plans reviewed by County EMA
- ❑ Checked against IEMA requirements
- ❑ Checked for local coordination / integration
- ❑ Copy kept at County EOC
- ❑ EOP is locally approved on behalf of IEMA
- ❑ Review exercises, training, documentation
- ❑ Certification of EM Program by County review



Example: Flood

- ❑ Village of Gurnee has experience (1996, 2004)
- ❑ 2007: Countywide flooding (not just Gurnee)
- ❑ Multiple DIRECT requests for Navy help
- ❑ County became single coordination point
- ❑ Got the help to communities where needed

Example: Public Information

- ❑ 2008: Countywide flooding
- ❑ Media saturation of region
- ❑ Some communities felt overwhelmed
- ❑ County implemented Joint Information System
- ❑ Multiple coordinated press briefings

Take NOTHING for Granted

- ❑ TEST your plans
- ❑ TEST your people
- ❑ TEST your collaborators
- ❑ Don't ASSUME!



Exercise Program

- ❑ Building-block sequence
- ❑ Set objectives and evaluate them
- ❑ Written After-Action Review
- ❑ Written Improvement Plan(s)
- ❑ Collaborate with others to reduce costs

- EOC Notification and Activation drill
- Resource Coordination drill
- Emergency call-down drill
- Tabletop Coordination exercise
- EOC functional exercise



Practice the way you've planned...

- ❑ Accept ALL feedback (bad is good... Really!)
- ❑ Exercise with your partners
- ❑ Hold people accountable to fix things!
